Section B Executive Summary

Executive Summary

The Toronto City School District is located in an economically-depressed area in Jefferson County, one of the thirty-two Appalachian counties in Ohio. Toronto is situated on the banks of the Ohio River in a Tristate area bordering West Virginia and Pennsylvania. This area is very convenient for transporting illegal drugs and easy for residents to access them. The Toronto City School District has experienced various socio-economic challenges. Unemployment is high, median household incomes are low, and access to public transportation is limited. Thus, travel for medical treatment and educational opportunities is a present, on-going need. The district's scores on the Ohio Department of Education's local report card indicate a strong need for vigorous investment in 21st Century learning skills, including STEM coursework and early college courses, best provided on site via telecommunication. This is a new opportunity as the district has never had telemedicine or distance learning services.

Toronto City School District is looking to implement a plan to address both the opioid crisis and the academic needs of its students. The district is requesting special consideration points for Opioid treatment. The predominant use of the system will be to provide access to opioid health education, treatment, and prevention programs. The district will have two end user sites J.T. Karaffa Elementary School and Toronto Jr.-Sr. High School, both located in Toronto, Ohio. The district will have three partners for the project. CHANGE, Inc. is located in Newell, West Virginia. Eastern Gateway Community College located in Steubenville, Ohio. Ohio FFA Camps located in Carrollton, Ohio. The project will service rural residents at J.T. Karaffa Elementary School (4,851), Toronto Jr.-Sr. High School (4,851), Ohio FFA Camps, Inc. (3,135), Eastern Gateway Community College (4,851), and Change, Inc. (1,376).

The total project budget is \$575,000 with \$500,000 being requested through the grant and \$75,000 being provided as a match from Cincinnati Empowerment Corporation. The telecommunications network will include provider distance learning carts, video system support and maintenance, touch control components/support/maintenance, cables/connectors, desktop video conferencing systems, multipoint systems, installation, and support. The systems will be instrumental in supporting a newly created Information Technology program for our students and families, providing critically needed tools to support them. Families will have access to health care on site, supported by additional healthcare professionals via telecommunications. Students will have access to dual credit offerings from Eastern Gateway Community College and STEM coursework and counseling workshops from our partnership with Ohio FFA Camps, Inc. Teachers will have expanded professional development opportunities to expand and enhance their own learning.

The district will partner with CHANGE, Inc. to establish and maintain a School Based Health Center (SBHC) adjoining the J.T. Karaffa Elementary School. Onsite health services at the SBHC will enable all patients to receive services, regardless of insurance or income, thus removing a significant barrier. Telemedicine equipment will enable the delivery of services to patients/clients at the Toronto site, thus affording direct access to a psychiatrist or other specialty providers.

Eastern Gateway Community College will provide exciting, new educational opportunities to Toronto's students. Eastern Gateway CC will offer courses designed to help students transfer to a

four-year institution or enter the workforce immediately. Through the use of telecommunication equipment, students will be able to interact with faculty, access course work, and experience the challenges and excitement that is inherent in any innovative educational program, without any barriers such as travel or cost.

Finally, the Toronto City School District will use distance learning systems provided through the grant to connect to Ohio FFA Camps, Inc., located in Carrollton, Ohio. This will enable students to have year-round access to STEM educational programs, as well as, access to the camp's peer prevention programs for drugs and alcohol.

In conclusion, the Toronto City School District will use the USDA Distance Learning and Telemedicine Grant to accomplish the following: implement a comprehensive opioid treatment and addiction prevention program in conjunction with CHANGE, Inc. and Ohio FFA Camps; open a School Based Health Center in conjunction with CHANGE, Inc. to provide critically needed health services to Toronto's families; and install and utilize a robust telecommunications system, partnering with Eastern Gateway Community College and Ohio FFA Camps, to provide distance learning programs to students, thus encouraging academic success and bolstering interest in STEM coursework and job-ready skills

Goals

The goals of the Toronto School District are to use the USDA Distance Learning and Telemedicine Grant to accomplish the following:

- Implement a comprehensive opioid treatment and addiction prevention program in conjunction with CHANGE, Inc. and Ohio FFA Camps
- Open a School Based Health Center in conjunction with CHANGE, Inc. to provide critically needed health services to Toronto's families
- Install and utilize a robust telecommunications system, partnering with Eastern Gateway Community College and Ohio FFA Camps, to provide distance learning programs to students, thus encouraging academic success and bolstering interest in STEM coursework and job-ready skills

Narrative

History and Need

Toronto, Ohio, is located along the east bank of the Ohio River in a relatively remote area of Jefferson County on Route 7, approximately 18 miles south of East Liverpool in Columbiana County and 12 miles north of Steubenville, Ohio in Jefferson County. It is linked to West Virginia by two bridges that cross the Ohio River. However, travel from rural and remote areas of the tri-state area is often problematic due to numerous mountains and winding, narrow secondary roads. Poor driving conditions during winter are an impediment to travel, often halting it altogether. Public transportation is extremely limited, with only Weirton and Steubenville maintaining routes. Thus, travel for medical treatment and educational opportunities is a present, on-going need. Existing urban and industrial development is primarily sited in a series of narrow, low terraces that run north to south along the valley. Only 42.4% of the land mass is suitable for development. There are many closed small businesses and empty factories. Railroad tracks run along the river, as well as between houses, and often are right next to the road. Travel off Route 7 is on curving narrow roads, often not well cared for during the winter. 37% of the target population in and around Toronto have an income level 200% below the poverty level. The county's unemployment rate is 6.3%, compared to the state of Ohio's rate of 4.3%.

The Toronto City School District was recognized in 1889 by the Ohio Department of Education. Since that time, Toronto School District has experienced various socio-economic challenges, but the current need for advanced, sophisticated telecommunication services and equipment and combating the opioid crisis in the immediate area has brought heretofore unseen challenges. This area, like much of Appalachia and the surrounding counties of Columbiana in Ohio and Brooke, Hancock, Ohio, and Marshall Counties in west Virginia, is characterized by median house values below the state average, unemployment above the state average, per capita income below the state average, uninsured population higher than the state average, and access to health care below the state average. Toronto currently has an estimated population of 4,737 and has experienced significant declines in population since 2000. From 2000-2014, Toronto had a decline in population of 13.5%. The Toronto School District has 446 students enrolled in its elementary school, and 398 students enrolled in Jr/Sr high school. This District has a 4 year graduation rate of 87.7% and a 5 year rate of 96.2%, which earned them a component grade of B on the Ohio department of Education's report card for the district. However, the remaining scores indicate a strong need for vigorous investment in 21st Century learning skills, including STEM coursework and early college courses, best provided on site via telecommunication.

Toronto's location is conducive to drug trafficking, contributing to horrifying statistics. A nationally broadcast news story from September 9, 2016 has become emblematic of the severity of the opioid crisis in this area. This news story shows a couple unconscious from a drug overdose in the front seat of their SUV, while a four-year-old child is sitting in a car seat behind them. This was filmed in East Liverpool, OH, near the intersection of Route 11 and Route 7. Countless media sources have reported that the Route 11-Route 7-Route I70 corridor is a favorite of drug suppliers. A recent publication by the West Virginia Drug Enforcement Administration states that Steubenville is source city to drug users and suppliers from both Chicago and Pittsburgh. Jefferson County and its neighboring counties are characterized as having easy access with bridges and highways, making this area very convenient for transporting illegal drugs and sadly easy for residents to access them. Hospital admission for Opiate Abuse and Dependence reached 39.4% in 2017, an increase of 11% since 2011. Ohio ranks second to West Virginia in the opioid overdose death rate of 39.1, revealing a 30.79% increase from 2015 to 2016. Illicit drug use among persons 12 years and older is 4.7%, and the percent of non-medical use of pain relievers is 5.6. Jefferson County reports the most recent data on death rates from opiates is 29.7 per 100,000. According to the Ohio Department of Health, unintentional drug overdoses in 2016 were up 32.8% from 2015. Jefferson County ranks 79 out of 88 counties in Ohio for overall health.

Because the opioid crisis has long ranging effects on the community and all residents, the Toronto School Districts is looking to implement a plan to address both the opioid crisis, the needs of its students both academic and social, as well as addressing these needs with the families and other residents. To this end, the district is looking to CHANGE, Inc. to establish and maintain a School Based Health Center (SBHC) adjoining the J.T. Karaffa Elementary School. This SBHC will be the only SBHC east of Columbus and south of Cleveland, with he exception

of one in northeast Ohio. The SBHC will have access to the Family Medical Care Community Health Center in Weirton, WV, a Federally Qualified Health Center that provides preventive, primary, women's, behavioral, vision, and oral healthcare services. Onsite health services at the SBHC will enable all patients to receive services, regardless of insurance or income, thus removing a significant barrier. Telemedicine equipment will enable the delivery of services to patients/clients at the Toronto site, thus affording direct access to a psychiatrist or other specialty providers. The SBHC will also be able to address the related issues of potential HIV and Hepatitis C outbreaks, as well as the increase in family sex trafficking in minors. The other related issue that will be addressed by the SBHC is the number of women who test positive for drug use while pregnant. CHANGE, Inc. reports that to date in 2018, 114 out of 380 pregnant women tested positive for drug use at their initial obstetrical visit, with 54 for them positive for opioids and other synthetic drugs.

Toronto School District is also going to look to Eastern Gateway Community College to provide exciting, new educational opportunities to its students. Eastern Gateway CC is a public, accredited institution that offers degrees, certificates, programs, and courses designed to help students transfer to a four-year institution or enter the workforce immediately. Previously known as the Jefferson County Technical Institute, it was chartered for operation in September of 1966, as a public two-year institute by the Ohio Board of Regents. Eastern Gateway participates in Ohio's College Credit plus Program, which provides students with the opportunity to earn high school and college credits at the same time. There is no cost to the student or family for courses and instructional materials. All students are assigned an Advisor who has the responsibility to ensure that the student has someone with whom he or she can meet to provide guidance. Eastern Gateway offers several General Education Course that meet the Ohio Transfer Module, thus guaranteeing the transfer of credits. Through the use of telecommunication equipment, students will be able to interact with faculty, access course work, and experience the challenges and excitement that is inherent in any innovative educational program, without any barriers such as travel or cost.

The other partner looking to support the Toronto School District in its goal to expand, increase, and invigorate learning experiences for its students is the Ohio FFA Camps, Inc., located in Carrollton, Ohio. The district has been participating in the environmental educational program for sixth grade students that provides a residential experience through their Nature's Classroom program that also promotes interest in STEM education. Nature's Classroom gives students a new perspective on learning and living through our camp philosophies. Challenge by Choice is a philosophy that allows the campers to participate in the camp activities where they feel comfortable. These two philosophies, along with sensory awareness, conservation, and responsibility are all woven into the activities at Nature's Classroom. The RUS Distance Learning and Telemedicine Grant will provide distance learning systems so that Toronto's students can have year-round access to programs, as well as access to their peer prevention programs for drugs and alcohol.

Conclusion

The USDA Distance Learning and Telemedicine Grant will enable the Toronto School District to achieve its goals and make an important, significant impact on every single resident, either directly through accessibility to services and educational opportunities, or indirectly through an overall improvement in every factor contributing to quality of life. This Grant will ensure that Toronto is transformed and ready for tomorrow.

Sufficient Resources

The Toronto City School District is a financially stable school district. The residents of Toronto strongly support the schools through their votes on Election Day. In the past twenty-five years, the district has a 100% passage rate for all issues that have been placed on the ballot including five renewal/replacement operating levies, one maintenance levy, and one bond issue to build a new jr.-sr. high school. The district will break ground on a new elementary addition in the summer of 2018. The elementary addition is a ten million dollar Ohio Facilities Classroom Construction project. The district did not have to put a bond issue on the ballot for this project. The district's four million dollar share came from existing district funds.

With the opening of the new Toronto Jr.-Sr. High School in 2013, the school district has attracted over one hundred students from neighboring school districts through open enrollment. According to the five-year forecast, the district will continue to maintain a June 30 cash balance from FY2018-FY2022 ranging from 2.6 million to 3.3 million. NARRATIVE

HISTORY

CHANGE, Inc. (Christians Helping Arrange New Growth Enterprises) Community Action Agency was formed in 1983 by a handful of clergy members who wished to aid families affected by layoffs from Weirton Steel find new employment. Since that time, CHANGE, Inc. has grown into a multifaceted agency, addressing many of the needs of the economically disadvantaged. With over thirty-five years of operation, the focus of empowering families is still strong within the agency.

CHANGE, Inc., a non-profit Community Action Agency, provides programs to families residing in the Ohio Valley, including Housing, Transportation, Nutrition, Emergency Services, Weatherization, a Domestic Violence Shelter, a Child Advocacy Center, Family Medical Care (FMC), a Federally Qualified Health Center (FQHC) that provides preventive, primary, women's, behavioral, vision and oral healthcare services, and a 340b Pharmacy. CHANGE, Inc. operates two School Based Health Centers (SBHC) in West Virginia and one in Jefferson County, Ohio. The SBHC in Jefferson County, Ohio is the only SBHC east of Columbus, south of Cleveland, with the exception of one in north-east Ohio. Program design is driven by the needs of the community, and the mission remains to "encourage the integration of services, the building of partnerships, and the pulling of resources to empower families towards healthy self-sufficient living."

CHANGE, Inc. has been providing healthcare services since 1998 and has expanded the number of patients served as well as the number of services offered by restructuring from a "free clinic" model with limited patient eligibility to a FQHC that offers sliding scale fees to any and all persons, regardless of where they reside or their financial or insurance status. Upon transitioning, CHANGE, Inc. received approval from the USDA for a loan to purchase and renovate the current FQHC site. CHANGE, Inc. has a history of working with federal grantors, state departments, and charitable foundations to successfully fund programs which provide valuable services to the community.

The Comfort House Child Advocacy Center's was started in July 2007 and strives to serve victims of child abuse and provide a balance of safety, healing, and empowerment while pursuing the accountability of the offenders. In 2016 CHANGE, Inc. was identified as a leader in the community for outstanding success in delivering services to the indigent population and for the successful funding rate for outreach programs and was approached by West Virginia Department of Health and Human Services to assume the Comfort House. In January 2017 CHANGE, Inc. acquired the Comfort House, which provides a child friendly facility, and ensures abused and/or neglected children in Brooke and Hancock Counties receive child centered services that focus on their individual needs by assessing, investigating and offering a coordinated service response to the physical, emotional and legal dimensions of child abuse. The Comfort House is the only accredited Child Advocacy Center in the two county area, and in 2017 completed 178 interviews for child abuse cases.

AGENCY CAPACITY TO ACHIEVE RESULTS

The success of CHANGE, Inc.'s operating methodology is due in part to the commitment of the Board of Directors and the management team to involve staff members and patients in planning and decision making. CHANGE, Inc. believes this involvement instills a sense of ownership and shared responsibility that are critical to its long-term success. Regular staff meetings are held to facilitate communication, provide in-service trainings, and gather input and suggestions. CHANGE, Inc. maintains a line of authority from the Board of Directors to the CEO, who in turn delegates to management and staff as appropriate.

The CEO is directly employed by the Board of Directors and has the appropriate authority to lead and manage the agency, and select and dismiss staff. CHANGE, Inc. and its Board of Directors understand the importance of a strong management team. Through the CEO, the Board of Directors are assured that the strategic planning is accomplished and implemented, the mission of the agency is achieved, programs and services meet the need of the community, the fiscal and operational viability and stability of the agency is maintained, and the management structure is in accordance with Health Center Program Requirements and the Community Service Block Grant Organizational Standards.

All employees and the Board of Directors play a key role in strategic and operational planning, and work closely with community members and area service providers. The team's familiarity with internal capabilities and constraints enables a critical perspective to the planning process, and its responsibility for assessing progress and providing outcomes assists in plan revision.

Fund accounting capability is provided through CHANGE, Inc. The agency has over 30 years of proven success in managing grants. CHANGE, Inc.'s Fiscal Department maintains accountability for AR/AP, billing, reconciles all cash accounts on a monthly basis, updates the general ledger with journal entries necessary to produce financial statements, prepares monthly financial statements for management and presents such reports to the Board of Directors. The Fiscal Department also takes an active role in assisting the Board and management in developing the annual budget and overseeing the annual audit by gathering all necessary financial records.

The Board of Directors and management staff have implemented financial policies and procurement procedures, which are reviewed on an annual basis, or as needed, to ensure all financial statements are prepared and presented according to Generally Accepted Accounting Principals and all costs are allowable and in accordance with the terms and conditions of their respective federal award. On a monthly basis, the CFO presents the unaudited financial statements to the Board of Directors, CEO, and the Finance Committee.

SERVICE AREA

CHANGE, Inc.'s service area is know as the Northern Panhandle of West Virginia and is comprised of Brooke, Hancock, Ohio, Marshall and Wetzel County in West Virginia (WV) and Jefferson County in Ohio (OH), as well as the surrounding communities in West Virginia, Ohio and Pennsylvania. CHANGE, Inc.'s Family Medical Care Community Health Center (FMC) provides services to residents residing throughout Hancock and Brooke counties in WV and Jefferson County in OH but is also a recognized Federally Qualified Health Center and can serve any patient regardless of residence. The service area, like much of the Appalachian Region, is generally economically underdeveloped and its population largely low income. Though the services offered are beneficial to the low-income and uninsured population, FMC's target

population is the entire three county service area, as the disparities have shown to be great throughout the service area, regardless of the individual's income or insurance status.

Though the services offered are beneficial to the low-income and uninsured population, FMC's target population is the entire three county service area, as the disparities have shown to be great throughout the service area, regardless of the individual's income or insurance status. The general health status of the service area is poor, as those in poverty often forego health care for a number of reasons.

NEED

CHANGE, Inc. reviews patients by zip code annually to ensure the patient population is still within the current defined service area and within reach of a health center site. CHANGE, Inc. also conducts a community needs assessment every three years that encompasses the entire service area of CHANGE, Inc. and includes both qualitative and quantitative needs data regarding demographics, poverty, employment, education, housing, nutrition, health and crime. The assessment also analyzes the causes and conditions of poverty in the area, and develops key summaries on the top community and family needs of the population. The needs assessment is used extensively by management of CHANGE, Inc. to gauge the needs of the communities it serves and ensure the programs and services offered can meet the needs identified. Programs and services are altered, created and eliminated based on the needs of the community and the results of the Community Needs Assessments.

Substance Abuse Prevention and Treatment was identified as the second highest community need on the most recent needs assessment surveys, and was also identified as a top need in the interviews of area organizations. Area prevention agencies offer both in-patient and out-patient treatment programs, but the demand for the programs is high. CHANGE, Inc. received a federal grant in 2015 to expand its Behavioral Health Program to offer substance abuse treatment, counseling and education to the community to help address the need among the low-income and uninsured population. With telemedicine equipment, students will be able to have remote access to specialty care, without leaving the school premises, which is the safe-zone. This will aid in relieving the burden for in-demand programs and address the needs of those unable to obtain treatment through traditional programs. In 2018, CHANGE, Inc. was awarded a small grant to educate youth on the dangers of drug abuse.

Ohio ranks second to West Virginia in the opioid overdose death rate of 39.1, resulting in a 30.79% increase from 2015 to 2016 and West Virginia ranks number one at 52 per 100,000, a 25.3% increase from 2015 to 2016, according to the Center for Disease Control 2016 data. West Virginia Drug Enforcement Administration issued an unclassified report titled *The West Virginia Drug Situation* in May 2017, acknowledging controlled prescription drug abuse and trafficking is a problem for the entire state, and in 2015 contributed to 61 percent of state overdose deaths. The report also identifies the geographical area of the Northern Panhandle, which represents the region of CHANGE, Inc.'s business operations, stating service areas of nearby Steubenville, Ohio, a source city for users just over the border serviced by Chicago based gangs, and Pittsburgh-based dealers supplying Northern West Virginia. Brooke, Hancock, and Jefferson counties fall in an easily accessible area with bridges and highways, making it convenient for suppliers to transport drugs and unfortunately easy for residents and children to access.

With drug abuse comes many other social emergencies. The CDC ranked counties nationwide against risk factors for potential HIV and/or hepatitis C outbreaks resulting from the opioid epidemic. Of the 220 counties identified, Hancock County ranks 49 and Brooke ranks 76 nationally. Jefferson County is not nationally ranked, however it falls within high limits for the State of Ohio with 242 cases per 100,000 population, according to Ohio Department of Health. In addition, CHANGE, Inc.'s Child Advocacy Center completed 178 forensic interviews in 2017 for child abuse cases. With an increase in addiction, there has been an increase in family sex trafficking in minors. Perpetrators and victims are from the same family, making it hard to recognize and children are being made to believe it's normal. The exact number of cases is hard to track because cases are hard to convict. In order for conviction, there has to be a testimony and it's hard for the victim to testify against family especially when they've been made to believe it's normal. Trafficking is the 2nd largest criminal activity next to drugs and according to the Polaris Project, 73 percent of sex trafficking victims were between the ages of 12-23 when it began. It is important to be able to provide access to medical providers to address such social and health emergencies.

One of the goals of Community Action Agencies is to achieve partnerships among supporters and providers of services to low-income people. CHANGE, Inc. makes every reasonable effort to establish and maintain collaborative relationships with other health care providers in the service area, and coordinate service delivery with agencies serving the same populations. In that regard, CHANGE, Inc. maintains a number of formal and informal relationships with health care providers, educational and social service organizations, and encourages partnerships with the local educational institutes for internships and on-the-job training programs. Established collaborative working relationships are in place with other providers serving the area, and include sharing of resources for the common purpose of maximizing services.

Geographical / Transportation Barriers

The service area of School Based Health Center in Toronto, Ohio is nestled among the hills and banks of the Ohio River, and is commonly referred to as the "Upper Ohio Valley." The City of Toronto is located twelve miles from downtown Weirton on the west bank of the Ohio River in northern Jefferson County and straddles the villages of Empire and Costonia. The three counties of Jefferson, Hancock and Brooke are linked together by two bridges that cross the Ohio River, permitting easy access from one county to the other. Travel from rural and remote areas of the counties can prove to be timely as travel through the area can be hazardous, with numerous mountains, and narrow, winding secondary roads. Poor weather conditions during winter can add hours onto driving time, or prevent it altogether. Public transportation in the service area is minimal, with only two cities, Weirton and Steubenville, maintaining scheduled routes. Transportation to and from medical appointments is a present need in the area, as only CHANGE, Inc. offers the service.

Most of the existing urban and industrial development is in a series of low terraces running north to south along the valley. Only 42.4% of the total land mass in the region is suitable for urban development. The residents and businesses have changed the landscape of the area over the years to suit their needs for housing and industrial development. There are many closed, small businesses and empty factory buildings. Smoke rising over the decades from the once operational Blast Furnace, Coke Plant, and Basic Oxygen Plant has given the city a sooty, dirty, grayish

appearance. Railroad tracks run along the river, occasionally between businesses and homes, and at times are right next to the road, crisscrossing in many places. Travel off the main highway is on curvy, narrow two-lane roads, virtually hugging the mountainside.

Unemployment, Income Level or Educational Attainment

Of the service area and target population for Jefferson County, 37.3% have an income below 200% of the poverty level. The county unemployment rate is high at 6.3%, compared to the State of Ohio 4.3% and U.S. rate for the same time period of 4.1, and the Median Household Income averages to \$41,942 compared to the nation's \$53,889.

Health Disparities

One of the main barriers to health care still facing the service area and target population is the increased indicators for Behavioral Health.

The Community Health Status Indicators shows 8.4% of the service area population has had at least one major depressive episode in the past year, and the CDC wonder shows the rate of age adjusted drug poisoning deaths is staggering at 19. The County Health Rankings for the service area also show the population reports having an average of 4.5 poor mental health days, but the Mental Health Provider Ratio is now 991:1, compared to 1800:1 just three years ago.

The rate of drug-induced deaths in WV was higher than the national average, and the percentage of drug treatment admission rates for non-heroin opiates reached 59% in 2010. According to the Ohio Department of Health, in 2016 unintentional drug overdoses were 4,050 up 32.8% from 2015. The most recent Jefferson County death rate is 29.7 per 100,000. Opioids as a single ingredient became the leading drug exposure reported to the WV Poison Center, and the leading prescription drug reported to the WV Drug Abuse Quitline was oxycodone. Discharges with a drug related diagnosis have steadily increased to 506.5 per 10,000 discharges, and the rate of acute hepatitis C has more than tripled in West Virginia.

The Unduplicated Admissions for Opiate Abuse and Dependence for Jefferson County reached 39.4%, an increase of 11% since 2011. Over 35% of clients in treatment listed prescription opioids as their primary drug of choice, the emergency room discharge rate for opiate-related diagnosis sits at 19.9, and the five-year average hospital admission rate for opiate-related diagnosis is up to 42.8%. The discharge rate for neonatal abstinence syndrome in Jefferson County is 23.6, which skyrocketed from 1.2 in 2004-2008. The WV Behavioral Health Epidemiological Profile showed alcohol use among persons 12 and older reached 43.4%, and the DUI rate has steadily increased to 39.6. Illicit Drug Use among person 12 and older sits at 4.7, and the percent of nonmedical use of pain relievers in the past year is 5.6. The morbidity rate per discharge reached 384.2, and the mortality rate was 31.3. Jefferson County ranks 79 out of the 88 counties in Ohio for overall health.

CHANGE, Inc.'s FMC is directly seeing this epidemic. To date in 2018 of the 380 confirmed pregnancies, 114 patients tested with a positive toxicology screening at their initial OB visit, 54 of those pregnancies were positive for opioids and other synthetic drugs.

GOAL

The goal of CHANGE, Inc. and collaborative partners is to provide the means to start addressing behavioral health issues with children within a neutral, familiar environment, our School Based Health Center, and to provide the rural communities direct access to mental health providers.

CHANGE, Inc. employs a Behavioral Health team, including a Psychiatrist, licensed clinical social workers and providers with DATA waivers, to offer on-site comprehensive mental health and substance abuse services to the patients of FMC. The expansion of behavioral health was seen as vital to operations after word came that the local hospitals would no longer be accepting uninsured patients, and the recent opioid crisis. CHANGE, Inc. was recently awarded a Community Services Block Grant to Educate Youth on Prescription and Opioid Drug Abuse through West Virginia Development Office. Licensed Clinical Social Workers will provide educational materials and activities to youth grades K-12 in Hancock and Brooke Counties in West Virginia with age appropriate material in effort to teach kids about the dangers of drug abuse.

Onsite behavioral health services enables all patients to receive services regardless of insurance or income and to receive quality care that can help them better cope with the mental issues they are experiencing. In order to bring mental health services to those directly at the school based health center and in rural communities, CHANGE, Inc. plans to install telemedicine equipment at both FMC Weirton and FMC Newell locations with a portable device at the SBHC Toronto. By establishing remote linkage from Toronto SBHC to FMC Weirton and FMC Newell we are affording direct access to a physiatrist or other specialty providers.





Project Description:

The Toronto School District is committed to creating a School Based Health Center (SBHC) and an expanded, revitalized distance learning system to provide medical services to our families and expanded access to online learning opportunities, including but not limited to college courses and STEM coursework, in addition to online education, counseling, and mentoring about drug addiction and its consequences. Toronto SD will provide a seamless system for both the SBHC and for use in classrooms and by our partners. All students and faculty will have a fully integrated set of tools and training in distance learning and accessing services via telecommunications equipment, based on best practices from industry experts both in distance health care services and distance learning. This project has been carefully designed to ensure ease of use and accessibility by our students and teachers, distance learning providers, and partners who have expertise in providing health services via telecommunication systems and to remove barriers that may be currently present.

Distance Learning Systems

Each location in this project will receive a video system consisting of a Utility Cart with integrated audio and lab components. Installation and 3 years of annual maintenance, as well as shipping are also requested. This system will be used exclusively for providing healthcare services (in conjunction with a Family Medical Care site that is a Federally Qualified Health Center), distance learning and counseling connections between sites. All of these products and services are eligible per the application guide and will be used only for approved purposes.

This equipment will be used exclusively to support this school based health center/distance learning initiative and only for 100% DLT approved purposes. The systems will be instrumental in supporting a newly created Information Technology program for our students and families, providing critically needed tools to support them. Families will have access to health care on site, supported by additional healthcare professionals via telecommunications. Students will have access to dual credit offerings from Eastern Gateway Community College and STEM coursework and counseling workshops from our partnership with Ohio FFA Camps, Inc. Our teachers will have expanded professional development opportunities to expand and enhance their own learning. Additionally our strong science and math department programs will see opportunities to add STEM activities that we currently lack as we have little access to urban areas as our rural location inhibits easy travel to participate. Our current College Credit Plus program will see expansion as we have the opportunity to provide even more dual credit

options, giving our students the potential to achieve an associate's degree along with their high school diplomas. In addition, our high school students will be able to mentor our younger students as they share STEM projects back to the elementary classrooms as students become teachers of their younger peers. Learning can be enhanced through virtual field trips, career education sessions, STEM contests, and weekly speaker series with content matter and industry experts. Student and adult learners can connect with guest speakers across the globe. Staff and administrators can participate in professional development activities and meetings from sites across the district and state, rather than traveling for District Leadership Meetings. Board and community meetings, sports and special events can be shared, thus promoting a sense of community.

Provide Distance Learning Carts

As partners in this project, Eastern Gateway Community College, CHANGE, Inc., and Ohio FFA Camps, Inc. will receive systems with the same components and capabilities detailed above. These will provide key capabilities to support teaching and learning, including point-to-point and multipoint video conferencing and the delivery of desperately needed health care services. EGCC will be providing more dual enrollment courses and programming and coding instruction for our students as we seek to expand STEM related dual enrollment courses to our students. Users will include college instructors delivering dual enrollment courses and college students providing STEM programing to students.

Video System Support and Maintenance

The distance learning network at Toronto School District will include valuable support and maintenance to ensure equipment is always available to meet the goals of our program. Without appropriate support, our program cannot be guaranteed to be available for our students.

Touch Controls

While having these new health care services/distance learning resources available will be a valuable asset to the Toronto School District, families, teachers, and students, the ability to appropriately run the equipment is just a valuable. The touch control components for both our classroom and providers is essential to the seamless integration of the equipment into the learning environment.

Touch Control Support and Maintenance

As with support and maintenance for the video system equipment stated above, the touch controls also require support to guarantee program availability for our students.

Telemedicine Carts

The Toronto Junior/Senior High School will use the School-based telemedicine program with Eastern Gateway Community College to increase the availability of care for the students to help keep our children healthier and reducing the number of absences due to illness.

AMD's Telemed ED, a clinical telemedicine system allows children to be easily seen by a healthcare provider without having to leave school for an appointment.

Installation

Toronto School District supports many students with a small information technology department. While they carry multiple duties, distance learning equipment is an area outside of their expertise, and the department have additional time to devote to installation. Professional installation is critical to ensure equipment is properly setup and functioning.

Training

As this is a new endeavor for the Toronto School District, appropriate professional development and training for teachers, administrators and technology staff is critical to the success of the program. This will ensure that end users are not frustrated with the new system from the beginning. The District will support professional development time for users to be trained and become comfortable with the new equipment.

Shipping and handling

Funds will be utilized to properly ship equipment to the three sites in the district.


Discussion of Equipment and Network

The Toronto School District has had discussions with multiple vendors to determine what video distance learning equipment will best meet our vision of creating a SBHC and expanded, enhanced distance learning opportunities. We have a sample list of appropriate equipment, software, support services and materials that will be needs to support the implementation of a robust distance learning network. We have considered various scenarios that will help achieve our goals of implementing both programs via telecommunications systems. Consideration has been given to the use of mobile carts with STEM lab components, interactive display boards, group counseling sessions, small group learning environments, and the appropriate levels of support and maintenance needed for all.

Possible Duplication of Services and other USDA grant applications

Toronto School District has never had a distance learning program or a SBHC. The district has lacked the opportunity to implement distance learning because we lack funding for the equipment we need. We have never participated in a USDA DLT grant in the past. There will be no duplication of services as this in the first time we have pursued any type of distance learning program or SBHC and funding for such a program.




